Updating report on taking ownership of Avon War Memorial

Report of committee clerk

1 Purpose of the report

To update the committee

2 Background

A motion was put to the committee by Councillor Price at the meeting on 30 January 2024.

An initial figure of £150 was put on the cost of moving the memorial. This was based on informal discussions with Ayliffe Builders.

It was resolved to take ownership

3 Current Situation

The Amenities Manager has been advised that the memorial would have to be moved closer to the road for Ayliffes to pick it up. The Amenities Manager, members of the Amenities Team and the Committee Clerk have visited the site. The memorial is large, heavy and firmly embedded in the ground. The Amenities Team would not be able to move it closer to the wall.

The possibility of removing the top section, which could then be moved by hand, was discussed. Because of the danger of damaging the memorial beyond repair, this was considered too great a risk for the Amenities Team to undertake this. The Committee Clerk then asked Sandridge Stone to take a look and they reported that the memorial was solid concrete, not rock and they could do nothing but felt that it may be possible to remove the top section.

Head of Operations then asked a local builder who have worked with the council before to take a look. Their quote for excavation, removal and delivery for storage is attached to the agenda.

Should the Amenities Team be asked to undertake the task there is a risk of injury to the team and damage to the memorial.

6 Recommendations

Committee to decide on next steps. There is a degree of urgentcy as Cooper Avon have confirmed they vacate the site completely on 27th March 2024. It is unlikely that any demolition work will commence in the near future but our access to the site cannot be guanarteed after 27th March 2024.
