Responses to Letter

TransWilts Community Rail Partnership

Thank you for copying me into your letter sent to Mark Hopwood on behalf of Melksham Town Council. The TransWilts CRP also notified GWR of our concerns over cancellations.

On 11 August, 8 out 13 trains through Melksham were cancelled. Our Membership Secretary began receiving calls at 6:30 in the morning on the 17th. On that day, the first six TransWilts services were cancelled.

I contacted the Head of Regional and Welsh Development at GWR, Dan Okey, who is also a Director of the TransWilts Community Interest Company, to find out what were the reasons for the poor service. He did investigate it as promised and insufficient staffing was the issue on 11 August and also featured heavily on 17 August too.

We are tracking GWR performance across the area of TransWilts, The screengrab below shows the performance of Melksham Station's Trans Wilts services over the last 12 weeks. It includes the extremely poor service provided on 11 and 17 August as well as the weekdays and weekends when it was not as bad.
