Minutes of the Economic Development and Planning Committee meeting held on Thursday 9th January 2025

PUBLIC PARTICIPATION: Two residents, three representatives of The Stantonbury Building and Development Company Ltd and two MWPC Councillors were present.

201/24 Apologies

Apologies were received from Councillor Oatley, who was substituted by Councillor J Westbrook, and Councillor Alford.

Councillor Aves had sent apologies but this was not known during the meeting.

202/24 Declarations of Interest

The Deputy Town Mayor Councillor Rabey advised that in her day to day employment she supplied work vehicles to Stantonbury Building and Development Company Ltd.

203/24 Public Participation

Public Participant.

PL/2024/10345 Land North of the A3102.

While I am not fundamentally opposed to the development, I believe significant concerns must be addressed regarding access and infrastructure before approval is granted, and then enforceable assurances put in place to ensure compliance. Firstly, alignment of access routes is a critical issue. The current proposal relies on insufficiently designed routing via the emergency vehicle access to Redwing Road, and closed-off rights of way, such as the Melk103 footpath, which is overgrown and inaccessible. Integrating pedestrian access with this footpath without proper improvements creates confusion and safety risks for residents. Secondly, the vehicular access routes from the A3102 to the proposed estate present serious concerns. The junction near the Skylark Road entrance is already problematic, with speeding vehicles and congestion issues. Without major improvements, including a well-designed access point, the safety of residents and road users will be at significant risk.

To ensure safe pedestrian access, crossings must be established on the A3102, particularly near the roundabout, to link the new development to schools and the Eastern Way pedestrian and cycle routes. These crossings are vital to provide children and families with safe, direct routes to Forest and Sandridge School and any future educational facilities.

Finally, the speed limits on the A3102 and Eastern Way must be reduced to 30mph to reflect the increased residential density and ensure safety for all road users. A consistent speed limit through the newly developed areas is essential to manage traffic flow and protect pedestrians.

In summary, without addressing these key issues—safe access routes, improved junction designs, pedestrian crossings, and reduced speed limits—the development risks creating significant safety and infrastructure challenges. I urge the committee to prioritise these concerns before granting approval.

204/24 Minutes

The minutes of 10th December 2024, having previously been circulated, were approved as a correct record and signed by the Deputy Town Mayor Councillor Rabey.

Councillors asked questions and raised some concerns around EV Charging provision, pedestrian access to public transport, flooding, orientation of houses, commercial units and the possibility of allocating one of these to medical services. Members noted and concurred with the comments of Highways.

UNANIMOUSLY RESOLVED to suspend Standing Orders.

Councillor David Pafford of Melksham Without Parish Council confirmed that MWPC were considering the application next week. Introduction states JMNP and the WC Local Plan have no weight because they were at the pre-submission stage. Both those documents have now been submitted and we are in the consultation period, run by WC. They will then go to examination and referendum. Contrary to developers claims, both plans are well advanced. December changes to NPPF indicated the validity of the process. NHP Group would submit that there is great weight behind the plan. Comment on housing numbers is, in his view, an attempt to take advantage of WC difficulty in building land supply. Applications is opportunistic and speculative. Not plan led. Site does not appear in either JMNP 1 or 2, the core strategy or the WC Local Plan. Housing numbers proposed under JMNP and Local Plan exceed the number of houses required to be built in Melksham by 2038. Unsustainable development. A Green Field development remote from employment opportunities and amenities. Traffic on Woodrow Road, Forest Road and north to Lacock already dire. Lacock Council very concerned about the number of vehicles from Melksham going through the village. Route goes via a bridge that frequently floods, making the route impassable. Traffic going south would have to come down Forest Road which is already a nightmare, and ends up in the Town Centre via Lowbourne where there will be construction traffic once the development of the old library starts.

Proposal is to develop about a third to a quarter of the site. This would be an example of "Trojan Horse" development. Permission is to build 70 houses in one corner and then developers come back with further proposals. Melksham needs plan led development. Both Councils and NHP Steering Group, with the support of WC, are very firm on this. Would ask MTC to oppose.

It was proposed by the Deputy Town Mayor Councillor Rabey, seconded by Councillor Westbrook and

UNANIMOUSLY RESOLVED to reinstate Standing Orders.

Members agreed with the comments of Councillor Pafford. Concerns were raised about increased traffic, lack of public transport and safe pedestrian routes to town and services. Members felt that the infrastructure was not in place to cope with this development and particularly noted comments from RUH Bath. Members noted and agreed with the comments of Highways.

It was proposed by Councillor Stokes, seconded by Councillor Griffin and **UNANIMOUSLY RESOLVED** to oppose the application.

212/24 PL/2024/10345

As with the other development concerns were raised about increased traffic, lack of public transport, safe pedestrian routes to town and services and inadequate infrastructure. Again members noted and agreed with the comments of Highways.

Standing Orders were suspended to allow Councillor Pafford to speak. He confirmed that this is a Strategic Site identified in the Local Plan and it was therefore likely that Wiltshire Council would be in favour, although not necessarily in favour of all the proposals. MTC & MWPC should be looking to agree the conditions, improvements and facilities they would like imposed on permission. MWPC have had pre-app meetings with developers. Have been understanding and prepared to listen and change plans.

Standing Orders were reinstated

Members felt that the application could be supported at the right time and with suitable conditions imposed.

Standing Orders were suspended to allow a member of the public to speak.

Public Participant

Accepts and supports the need for housing. Agrees with comments on infrastructure. Lived in area for 20 years and seen increase in flooding and traffic. Wanted clarification on the site and areas marked as not suitable for development. Councillor Ellis and Councillor Pafford offered to speak to the resident after the meeting.

Standing Orders were reinstated.

There was discussion on the way forward.

It was noted that MWPC would be considering the application on 13th January. It was agreed that the committee clerk would send a summary of the discussion to the MWOC clerk. Councillor Ellis would attend the meeting and report back. The chair Councillor Rabey and the committee clerk were delegated to meet after MWPC had considered the application and formulate a MTC response.

It was suggested that this matter be deferred until the Gompels planning application had been considered.

It was proposed by the Deputy Town Mayor Councillor Rabey, seconded by Councillor J Westbrook and

UNANIMOUSLY RESOLVED to suspend Standing Orders to allow Councillor Pafford to speak.

He noted that MWPC had recommended a roundabout when the school was being considered. Wiltshire Council had a Strategic Site allocated to the east of the school which would require an entrance point which could be a roundabout with an entrance to the school.

It was proposed by the Deputy Town Mayor Councillor Rabey, seconded by Councillor Stokes and

UNANIMOUSLY RESOLVED to reinstate Standing Orders.

Members felt they were unable to take this matter forward at this time for the reasons discussed.

227/24 Neighbourhood Plan

Councillor Ellis advised that an examiner was being chosen and a meeting of the Neighbourhood Plan Steering Group was being arranged.

The item was noted.

228/24 East Melksham Community Centre

The committee clerk advised that efforts had been made to find out what was happening with the gifting of the land and solicitors had been notified of the location. A chase up has been sent to the developers.

It was proposed by the Deputy Town Mayor Councillor Rabey, seconded by Councillor J Westbrook and

UNANIMOUSLY RESOLVED to suspend Standing Orders to allow Councillor Pafford to speak.

The Clerk of MWPC was trying to confirm a definite date when the three year period for construction commences or commenced. It had previously been indicated by Melksham Town Council that there should be two centres, one in the town and one in the parish. Current available sites were considered to be too small. It may be the way forward would be to find a new site to build one big centre jointly.

It was proposed by the Deputy Town Mayor Councillor Rabey, seconded by Councillor Griffin and

UNANIMOUSLY RESOLVED to reinstate Standing Orders.

Hi Andrew and Hugh

The parish council would like to arrange a meeting of the joint CIL Working Party.

This was 3 members of each council, I am not sure if you have appointed reps this council year, we have not met for a while as we jointly did not have much CIL money between us then.

Our reps are Cllr Glover, Cllr Pafford and Cllr Baines.

We can do during the day, I am not sure how your councillors are fixed for that, or you would prefer an evening/early evening?

It would also be useful to know what you have in the shared pot; to inform the meeting/ decisions. I did copy both of you in to an email a couple of weeks ago about your published reserves, to remind the town council that some of the CIL reserve was for jointly agreed projects.

So, as we have an adopted Neighbourhood Plan, which means the council that the planning application is in, now gets 25% of the CIL that Wiltshire Council gets, and not 15% as before. This additional 10% is because of the joint plan between MTC and MWPC and we agreed to put in a shared pot and use for joint projects. The only one agreed to date is the Real Time Information in the bus shelters. The town council vetoed the other suggestions of the parish council.

We anticipate having 34,011.18 at year end 31st March 24, and 38,419.34 during 24/25 in the 10% pot.

For background info:

The CIL working party met on 19th July 2022.

Both councils considered projects to put forward at their respective full council meetings on 3rd October 2022.

At our meeting on 24th October 22 we report that we had heard verbally from the town council that they had not agreed to our suggestion of improved walking routes, but just to the Real Time Information. I don t think we ever heard anything more from the town council. I recall agreeing with Patsy that it wasn t worth meeting as there was only about 5k between us in the pot in 2023 so not worth meeting, but that is not the same now. Off the top of my head you had some 50k+ in your CIL reserve, and might have more not in a reserve and so some of this is for the joint project?

Wiltshire Speed Survey Report

Introduction


Firstly, thank you to the 87 Towns and Parishes that responded. That is a really high level for a survey of this nature.

To reiterate – my objective is to establish whether the experiences of the Parishes within my Division on the outskirts of Corsham in North Wiltshire reflect those of other Parishes in the County.

Speed of traffic

The speed of traffic is clearly an issue in pretty much every Parish. The strategy to deal with the problem is quite varied and the response from Highways and LHFIG also quite varied.


The first chart below indicates that the majority of Parishes experience issues with the speed of traffic. Note for each chart the number of responses is listed – this will not always be 87 and needs to always be considered when attempting analysis.



Of those that experienced speed issues 45% had requested a Speed Limit Assessment, 63% used a Speed Indicator Device and 48% had set up a Community SpeedWatch Team. Which indicates that PCs consider the speeding issue is sufficiently serious to warrant action. However, when trying to get speed limits reduced around 50% of those had problems (see below)


Speed Limits

The reasons for those problems were varied and many answers were very detailed. The top 5 reasons given are listed below.

If you anwered Yes to the previous question was this due to 50 responses



From the above responses there appear to be around 40 Parishes that encountered problems with Speed Limit Assessments and of those 24 cited either Highways or LHFIG as the obstacle.


Speed Indicatore Devices(SIDs)




ANPR cameras

Comments

The following is a small selection of the numerous comments made (thank you – I have read them all).

PARISH NAME REDACTED ...had the speed survey/metro count, which did not show a theoretical problem. Our problem is that it is national speed limit right through the village, with no pavements etc. LHFIG considers that a speed limit review would be a waste of resources as unlikely to recommend the installation of a limit. LHFIG are now open to discussion about some road markings etc

The results so far from our traffic surveys fall within the 85th percentile indicating to WC that there are no real speeding issues, however on narrow roads with no pavements 30 miles an hour is too fast.

Wiltshire council have done speed surveys and while we did have speeding it wasn't enough to be considered a problem and thus leaving us very little to actually do to slow traffic down all while still getting complaints from residents that the traffic is too fast and pedestrians (a lot of families with small children walking to and from primary school and preschool) are feeling unsafe.

We have not asked for speed limit to be changed we have tried to educate drives with SID and this has worked. There is no need for any part of the parish to have speed limit altered

We are about to apply for 20mph for school area. We wanted to extend a 30mph limit some years ago but there were not enough house frontages. It seems to take a long time to apply and get SID's installed.

We have not applied for a speed limit change - we would like to do this, guidance on doing this would be greatly appreciated.

Summary

The speed of traffic is considered an issue in many Parishes and the response from Wiltshire Council a mixed experience.

My opinion

The speed of traffic is a major issue, particularly in rural areas. Perhaps it is more of a problem now with greater volumes of higher performance cars on rural roads. Perhaps SatNav doesn't help by driving motorists off the main roads.

Historically the emphasis of Wiltshire Highways has been to optimise journey times and this was probably a commonly held objective. As a result, the weightings that have been given in speed limit assessments has favoured the motorist. January 2025 sees the introduction of new requirements in Wiltshire for assessments to give more weight to the local experience of pedestrians, cyclists and also the motorist. Highways reported today (14th Jan) on how they will achieve these changes this week.

Up to now Highways have relied on reports from their external consultants in making assessments. These reports have focussed on metrics and an assumption that motorist behaviour will be only marginally affected by a reduction in speed limit. Hence, a reluctance to reduce limits and a similar reluctance of Parishes and LHFIG to fund assessments.

The Department for Transport Guidance on Speed Limits includes a great deal of criteria including that of considering vulnerable road users in a decision. This means that in villages with no pavement weight should be given to the impact of speed on the safety of pedestrians and active travel generally. However, this was only guidance and the ultimate decision-making is delegated to the Local Authority. Which is why I'm very pleased that Wiltshire's Cabinet has approved changes to broaden the criteria considered and consider the impact of speed on the local community.

I am not so naïve as to think that reducing speed limits is a panacea and will solve all issues of speeding alone. But I think it is the starting point. The first question should always be 'what is the appropriate speed for a section of road taking into account all users?', followed by 'how it can any change be achieved?'. For a decade or more the question has been 'how fast is the traffic moving?' followed by 'do we dare reduce it as the motorist may take no notice?'.

Delivering a change in motorist behaviour is a challenge. The use of SIDs is helpful with the inadvertent offender but probably has little impact on the persistent one. For this the daytime use of

a network of Parish Council owned cameras (eg. AutoSpeedWatch) could be a resource for identifying those who flout the limits and deliver a profile of behaviour that could be fed as intelligence to the Police for enforcement.

Enforcement at hotspots is already taking place with the use of data from SIDs by the Police but enforcement teams are a scarce resource.

Finally measures to introduce traffic-calming is a last choice coming, as it does, with a high price tag.

So, I am looking forward to seeing the new recommendations filtering down and Parishes and LHFIGs having confidence that their experiences are being listened to and acted upon.


