The Friends of Shurnhold Fields made the attached application to the parish council's Grant Funding scheme for 2025/26.

31. Friends of Shurnhold Fields: It was noted that this group had applied for funding for additional tools to aid the maintenance of Shurnhold Fields. The Clerk explained that as this was for the maintenance of the field, expenditure for this could come out of the s106 maintenance contribution, which was held in the parish council's accounts for the joint project with Melksham Town Council. It was noted that the town council did not give any delegated powers to the Shurnhold Fields working party to approve spend so any new spend from this fund would have to be considered by the town council. As it is considered that this funding request could come out of the maintenance fund, the parish council refuses this application. It was agreed that the council would contact the town council for their approval to spend money on items as detailed in the group's application for the maintenance of the field.

The space is used by young and old who want to enjoy a large open space, dog walkers, families that have little or no garden space, adults and children alike who like to explore nature with the stream an added bonus and those who just want to take advantage of the picnic spots to sit and enjoy the natural environment on their doorstep. It was totally invaluable during the pandemic when deprived families needed some outdoor space on their doorstep, bringing the community together, and has become the focal point for some exercise along with social interaction.

At present we are a volunteer group of approximately 10. The group arrange regular working parties to maintain the fields to make it an enjoyable, free, open space to visit for all local and neighbouring residents.

Ongoing planting/staking/pruning and maintaining trees continue, grass cutting walkways between features, access paths to the stream etc, cleaning picnic benches, upkeep of the wild flower meadow, maintain a tree nursery (raising trees to plant out when established) and general clearing of vegetation, weeding and stream clearing etc..

The money will be used for public liability insurance. Servicing our lawn mower. We also require additional garden tools/sundries as the team expands/tools break/get worn etc.

Garden tools to include - wheelbarrows/watering cans/ buckets General garden hand tools to include - spades/forks/trowels Tools for tree maintenance - secateurs/ tree loppers/pruners. Tools/sundries for working in the stream - waders/ waterproof gloves

We felt the events should be open to all and rather than ask for payment for entry forms we set up a Go Fund Me page and advertised the link along with the activity. We raised over £200. We will run similar activities again this year.
