The Town Council has received the following email.

I am writing with a request for a covered bus shelter to be installed at the bus stop near Queensway Chapel in Melksham. Currently this is a bus stop with bench seating. This bus stop is used by many many older people as the demographic of the immediate area will show. My Mum (84 years old) uses this bus stop on a daily basis, multiple times a day. There is no where for any customer to shelter from the elements, I've been stood there with Mum on many occasions getting absolutely soaked, holding an umbrella, I don't want my Mum or others having to wait exposed to the elements. Because this bus stop has no shelter, if the forecast is for bad weather the more frail generation are forced to walk (if they are able to walk this far) to town to wait for a bus where there is shelter. Those that are unable to get as far as town I assume are forced to stay in until the weather improves.

There is ample room to accommodate a perspex shelter that would prove very beneficial to local residents, one that would cause minimal, if any detrimental effect to anyone.

I would be very grateful if you could install a shelter ASAP, the weather is going to get worse this time of year so speed will be very much appreciated by all.
