# Joint Melksham Neighbourhood Plan 2

# **Purpose of Report**

To inform Members about the updated Joint Melksham Neighbourhood Plan (JMNP2), the upcoming referendum, with a particular focus on Melksham Town. To suggest key next steps in delivering JMNP2 within the Town Council area.

# **Background**

Melksham Town Council and Melksham Without Parish Council have worked together and are each responsible for the Joint Melksham Neighbourhood Plan JMNP2. The first JMNP was adopted in July 2021 and is the current adopted Neighbourhood Plan.

Both councils supported the immediate updating of JMNP. JMNP2 address additional issues and new priorities. It looks further ahead to 2038 with strengthened polices to manage planning applications. It boldly allocates two key town centre regeneration sites and sets locally shaped criteria for them. It designates and protects locally treasured Green Spaces, including 30 within the town. It has produced a Town Centre Master Plan to direct future improvements and deliver vitality and its has delivered a Design Guide to secure distinct high quality local development across the JMNP2 area.

The second plan has now successfully passed independent examination and is on course for a local referendum on 31 July. It must also pass this before it can come into force and replace the first issue of JMNP. Once adopted (or made), JMNP2 will become an equal part of the Wiltshire Development Plan. It will secure plan led development within our JMNP2 area for five years and all parties must give it full weight in preparing, assessing and determining development proposals within the JMNP2 area.

# The Presentation

Vaughan Thompson (MRTPI) of Place Studio, who has assisted JMNP2 Steering Group in producing the first and updated plans, will give a short presentation of JMNP2 elements and policies. He will highlight the key areas of the new plan that are of particular relevance to Melksham town area and its community. He will suggest next steps following the making of JMNP2 that can help deliver its vision, objectives and key priories. It is also an opportunity for Members to ask questions about JMNP2 and its future importance to Melksham.



**REFERENDUM - THURSDAY 31ST JULY** 

Working together with the community, Melksham Town and Melksham Without Parish Councils have updated the Joint Melksham Neighbourhood Plan (JMNP) to look ahead to 2038. The second edition of our Plan has successfully completed its independent examination, a major milestone on its road to coming into force and giving local voices more legal clout in the planning system.

The updated plan builds upon the first edition of the JMNP, which was voted on and adopted in July 2021. The second edition addresses the community's prioritised and updated issues including regenerating the Cooper Tires site and supporting town centre businesses, delivering more affordable housing choice, protecting our countryside and local green spaces, and stepping towards a zero carbon Melksham.

JMNP2 has been developed through extensive community involvement and consultations in 2023 and 2024. The valuable feedback gathered from residents and stakeholders has been thoughtfully integrated to ensure the plan genuinely reflects local needs and aspirations. The plan is robustly supported by a comprehensive evidence base that includes a detailed record of how JMNP2 has responded.

# Independently examined & evidence based.

In total, your Neighbourhood Plan sets out 21 bespoke local policies on design quality, sustainability, affordable housing, green space provision, and infrastructure contributions for Melksham town and the surrounding rural areas. They are evidence backed, tested through independent examination, and shown to be a positive way to directly shape the future of our town, villages and countryside.


# Your Plan conserves and protects

Green spaces: 49 important local green areas are given the highest possible level of protection. It means that, like protected green belts, it's very difficult to build on them, ensuring they stay green and open for everyone to enjoy, for nature, or for their special character.

Countryside between villages and the town: Our plan identifies and gives additional local protection to important areas of countryside to protect the setting of our town and villages and ensure they don't merge into one big built-up area. We want to make sure you can still tell where one place ends and the next begins.

Local heritage: The plan includes a 'local list' that provides increased protection to historic features which, while not statutorily listed, are considered significant to the local heritage of the area.

# Your Plan helps deliver plan-led, sustainable development


**Brownfield first:** A core objective of the plan is prioritisation of maximising the use of brownfield land. It allocates nearly 14 hectares (c17 football pitches) of vacant land at Cooper Tires and the Old Library, to promote the creation of homes, jobs, and a vibrant town centre.

Managed growth on green fields: Outside of the town, the plan aims to preserve the distinct identities of Shaw and Whitley villages whilst facilitating the delivery of much needed smaller and more affordable homes, including bungalows.

Reduced risk of speculative development: This is a significant advantage. Having an adopted Neighbourhood Plan with allocated sites gives the community and the Local Planning Authority more control over where development happens for the next 5 years.

Having successfully navigated the independent examination, the Joint Melksham Neighbourhood Plan 2 is now proceeding to a local referendum on Thursday 31st July. Only upon a successful referendum will the plan be officially adopted, superseding the first edition and providing an updated clear framework, with the same legal status as the Wiltshire Local Plan, for future development in the area.




# Fairtrade in Wiltshire

# Trowbridge Fairtrade Town Group

Trowbridge Fairtrade Town Group was formed in 2007 by a small group of volunteers to raise awareness of the principles of Fairtrade (FT) and the promotion of FT certified goods in the Town.

Working with the Town Council and local businesses, schools and churches the Group applied to the Fairtrade Foundation for Fairtrade Town status, which was awarded in February 2009. Since then, the Group has successfully maintained its status as a Fairtrade Town following application to the Fairtrade Foundation for renewal every 3 years. Trowbridge continues it's Fairtrade Town status until December 2026

# **Overview of Traffic Surveys**

Previously known as 'Metro Counts', the traffic surveys we undertake use equipment placed on carriageways which comprises of two rubber tubes stretched across the carriageway and a data box which is secured to street furniture. Data is collected for 24 hours per day over a 7-day period on the speed, volume and classification of vehicles. The equipment may be on site for up to two weeks with surveys only being conducted during school term times\*.

Wiltshire Council receives a large number of traffic survey requests over the year from Town and Parish Councils and from internal teams within the Council, to assist with transport related projects.

If you are a member of the public who would like to request a traffic survey, this should be made via your local Town or Parish Council who will submit an application form to Wiltshire Council on your behalf - we do not accept the request forms directly from individual members of the public.

Wiltshire Council will send traffic survey requests to our contractor in batches of 20 approximately once per month. Once the surveys have been completed, Wiltshire Council then process the survey data before it is distributed to the relevant town or parish council, Wiltshire Police's Community Speed Watch Team and the relevant Traffic Engineer for the area to ensure that our Highways are monitored and that everyone with interest remains informed.

The following information has been provided in order to guide you through the process of completing a Traffic Survey Request. Please read this carefully and provide as much detail as possible. Once the traffic survey has been commissioned, it cannot be cancelled, relocated or repeated. Please also note that traffic surveys cannot be repeated within a year on the same road.

<sup>\*</sup>Some traffic surveys may be requested during off-peak periods of the year by other teams within the Council. Please ensure that you check that they are happy for the surveys to be conducted out of the term-time period as the can impact the results significantly.

# **Site Selection Criteria for Traffic Surveys**

The following points MUST be followed when selecting a survey site. If the criteria are not met, the data quality will be poor, and results may not provide any evidence of the issues you have raised.

- For Community Speed Watch and community concern sites, traffic surveys will only be approved in 20mph, 30mph and 40mph limits, over 100m from a change in speed limit, with no traffic calming in place. Any sites that meet the criteria for a CSW scheme which are surveyed within 100m, will be rejected by the Community Speed Watch Team.
- Any locations with a posted speed limit of 50mph or 60mph will need approval from a Wiltshire Council Traffic Engineer before a survey is commissioned (please see Appendix 2 for a list of our Traffic Engineers and the Area Boards they manage). Please contact the relevant Traffic Engineer for your Community Area in the first instance, before submitting your request.
- Select sites where most traffic is travelling at a constant speed across the tubes. Wherever possible please avoid the following locations;
  - o roads where vehicles are accelerating or decelerating due to sharp bends and steep inclines
  - do not choose locations near traffic signals, junctions or near pedestrian crossings
  - roads with on-street parking
  - o and sites where vehicles may need to stop over the tubes.
- Ensure that traffic will cross at right angles to the tubes as far as possible. Avoid sites where vehicles may turn across the tubes or where vehicles may change lanes.
- Ensure there is a suitable securing point for the roadside unit. This could be road signs, street furniture or street lights. The data box is secured with a padlock and chain any posts must be tall enough so that the chain cannot be lifted over the top. Use of posts on private property will require permission from the landowner. Please see next point.
- Acceptable street furniture could be:

Various road signs, speed limit signs (with the exemption of speed terminals) Directional signs, street lights and trees that are on the highway and easily accessible



• *Unacceptable* street furniture;

Bollards/posts and private property such as fencing/gates (can only be used with owners permission – contact details will be required)





- Consideration for the safety of the deployment officers is paramount. Any
  location deemed too high risk for deployment will not be completed –
  notification of this will come from our contractors via Wiltshire Council and the
  relevant Town/Parish Council will be notified with an alternative suggestion.
- Please include as much information for the location as possible, including
  house numbers, official road name and/or number and maps. In addition,
  please include a <a href="www.what3words.com">www.what3words.com</a> link for the location, as this helps us
  and our external contractors to identify specific locations, particularly in rural
  areas. Please see Appendix 5 for further instructions.
- Locations are not eligible for repeat survey within a 12-month period, unless there are exceptional circumstances and approval from the Highways Officer.
- A desktop exercise will be performed by Wiltshire Council to ensure that all of the relevant information has been included on the form and check each location for site suitability. If there are any issues with the location you have selected, you will be contacted to discuss via email to confirm, prior to the survey.
   Incomplete forms without the above information will be returned to the corresponding Town/Parish Council.
- PLEASE NOTE There may be instances where the location that you have selected cannot be surveyed, and an alternative is deployed. In these instances, our contractor may raise concerns that were not apparent during the desktop exercise. The reasons for this may be due to poor visibility to carry out the installation safely, high volumes of traffic or the speed of traffic. However, our contractors will endeavour to relocate the survey equipment as close as reasonably possible to the requested location and are responsible for informing us as soon as the installation has taken place. We will of course do our utmost to keep you informed as soon as this information is made available to us.

A Wiltshire Council Highways Officer will try to answer any questions regarding the above points but are **unable to visit sites in person**. Please contact trafficsurveys@wiltshire.gov.uk for further help.

# **Survey Results**

Wiltshire Council are part of regional contract that covers the Southwest of the UK, along with many other Local Authorities. The aim of this contract is that one supplier is used for commissioning the traffic surveys for all contract members, to enable costs to be kept to a minimum and to ensure best value for money. This contract is renewed every two years; therefore, the presentation of the survey results you receive once your request has been completed, may vary during this time.

The survey results will be supplied via email to the corresponding Town/Parish Council and will provide details as previously. Please see **Figures 1 & 2** below for an example of a traffic survey report from one of our previous contractors and a more recent one from our current contractor.

# Speed Data

The traffic survey will record 85<sup>th</sup> percentile speed for each vehicle and this will be used to determine if the site enters the thresholds for intervention and detailed as follows;

Speed Limit (MPH)	No further action (85%ile)	Considered for Community Speed Watch (85%ile)	Police Enforcement (85%ile)
20mph	20 mph to 24 mph	24.1 mph to 38.9 mph	Over 39 mph
30mph	30 mph to 35 mph	35.1 mph to 41.9 mph	Over 42 mph
40mph	40 mph to 46 mph	46.1 mph to 49.9 mph	Over 50 mph

The 85<sup>th</sup> percentile is the speed at or below which 85% of the traffic is travelling. This is the standard method of assessing traffic speed in the UK. *Please note that Community Speed Watch teams cannot operate in areas with a speed limit over 40mph.* 

In addition to the recorded **85<sup>th</sup> percentile**, speed results are also provided to illustrate;

- o Directional speed data
- Weekly average speed data
- o Percentage of vehicles travelling over PSL (Posted Speed Limit).

# Traffic Volumes

Traffic volumes are recorded hourly and split into northbound/southbound or eastbound/westbound directions. These results are also categorised as follows;

- Combined vehicle volume
- Weekday average volume
- Weekly average volume
- Weekly total volume

# **Vehicle Classification**


The classification of each vehicle is recorded during the traffic survey by measuring the distance between front and rear axles as they travel over the two tubes. Again, this information is provided as a summary over the survey period and split into vehicle classifications.

Figure 1 – An example of a traffic survey report from our latest contractor Intelligent Data




# 'What 3 Words' Instructions - how to find your site location


- Navigate to <u>www.what3words.com</u>
- In the search bar at the top left of the screen, type in the address or postcode you are looking for e.g. Mortimer Street, Trowbridge.




 You will be given a choice of addresses as in the image below. Make your selection from the list and you will automatically be taken to the location on the map as shown in the next image. When given a road name to search, What3Words will automatically select a point on the road which is central. (see red and green highlighted locations on the map).




• You will see three completely random words are now in the search box which is where you will find your 'What3Words' location reference and a black box outlined. *However*, this location may not necessarily be the precise location you are looking for (e.g. street light no. 7 outside of numbers 94-96 Mortimer Street, Trowbridge). So, using the 'hand' tool, navigate around the screen to find your chosen location and click onto a box within the grid and ensure it has a black outline - each time you do this you will notice the 3 words in the search box change (you may need to zoom into the map to see the squares appear please use the zoom +/- button on the bottom right of the map).



- Once you have found your chosen location, please select the 'yellow man' at the bottom right of the screen (also shown in Google Maps). Click and drag him onto the map in the vicinity of your location as shown below. An image of the location will also be shown via Google Maps which will enable you to specify your exact location.
- Continue to navigate the yellow man to your chosen location using the hand tool and arrows and select the relevant box where he is so that the box has a black outline as shown in the next image.



Good afternoon

We have received a request for a traffic survey on the access road leading off of the Market Place past the Town Hall and down to the campus. I have had a look at the instructions for requesting a survey and it raises a few questions that I would like you opinion on before I put the request to a committee.

- (i) The guidance says to ensure there is a suitable securing point for the roadside unit. There is a lamppost at the corner of the town hall but it is not adjacent to the road so the chain would have to run across an area of public access. Where the fixing to a static item i.e. streetlight, crosses a footway I'm sure the traffic survey provider can provide ramped covers which the tubes slot inside. This avoids the tubes trailing across the footway.
- (ii) The guidance has different rules for different speed limits but I am not actually sure what the speed limit is on the access road. The speed limit on the access road (adopted highway part see screen shot below) is 30mph. No issue here.



- (iii) Does the fact that the majority of the length of this road is within the grounds of the campus? No, the traffic count can be installed near the corner of the town hall as you have proposed.
- (iv) The guidance asks that we avoid, if possible, "roads where vehicles are accelerating or decelerating due to sharp bends and steep inclines" and "locations near traffic signals, junctions or near pedestrian crossings". This would seem to apply as the road comes off of the Market Place roundabout. However, the whole point of the request is that the resident claims cars do not decelerate sufficiently. I think this relates lengths subject to strong braking or acceleration. I think you'll be fine in the location below. I fully expect average speeds well under 20mph here. I use the campus at least once per week and have never witnessed an issue with excessive vehicle speed.



# From Consultants to MWPC 1st July 2025

If you are able to share further details of their concerns, I will pass this onto the project team and will be back in touch to provide a formal response.

## From MWPC to Consultants 2<sup>nd</sup> July 2025

The concerns raised were about the lack of safe walking routes to the site. For pedestrians coming from the town (Bradford Road A3102) they will need to cross Farmers roundabout and the A350 to access the proposed site on the B3107. There are no pedestrian crossings on Farmers Roundabout, with the nearest crossing of the A350 being outside the entrance to Asda. Additionally there are limited or no pavements on the roads feeding into Farmers roundabout. A particular concern is the lack of a pavement between Asda (where a pavement is present) and the entrance to the proposed site.

There is a current adopted joint Melksham Neighbourhood Plan 1, but the emerging Neighbourhood Plan 2 has significant weight already, with its Referendum scheduled for Thursday 31<sup>st</sup> July. You can read more about both plans here <a href="https://www.melkshamneighbourhoodplan.org">www.melkshamneighbourhoodplan.org</a>

Policy 11 of the Joint Melksham Neighbourhood Plan 2 cover sustainable active travel and details that:

# **Policy 11: Sustainable Transport and Active Travel**

As appropriate to their scale, nature and location, development proposals should complement the Sustainable Transport Hierarchy, including provision for ultra-low emission vehicles. Proposals for major development should demonstrate through a proportionate Travel Plan how sustainable transport modes are maximised and that safe and suitable movement can be achieved for all people. As a key element in the local sustainable transport network, proposals that would achieve further improvements to the accessibility and quality of the links between the wider town and Melksham railway station will be supported. Improvements to the quality of the public realm around the station will also be supported.

I have included an extract of the Plan here, and included the whole section on "Shopping, Working and Getting Around" which cover proposals for the retention, intensification and reuse of previously developed sites, the active travel policy above, and also about the town centre. Your proposal is outside the town centre, but thought it might be useful too.

There is a current adopted joint Melksham Neighbourhood Plan 1, but the emerging Neighbourhood Plan 2 has significant weight already, with its Referendum scheduled for Thursday 31<sup>st</sup> July. # Town and Country Planning (Tree Preservation) (England) Regulations 2012

**Dead Dying or Dangerous Tree(s)** 

**Application Reference Number: PL/2025/05629** 

**Decision Date: 02/07/2025**

The Council confirms that the above Tree is classified as Dead and Dangerous (DD). The tree can be reduced under the Town and Country Planning (Tree Preservation) (England) Regulations 2012. This allows the removal of any protected tree, which is dead or imminently dangerous, without the need to make a formal Tree Work Application to the Council.



### **Notes**

Section 213 of the Town and Country Planning Act places a duty on landowners to plant another tree of an appropriate size and species, in the same or nearby place.

The new tree/s should be planted within the first available planting season following the removal of the DD tree. The replacement trees should be a suitable species and of similar stature (at maturity).

The applicant should note that this notice does not affect any private property rights and therefore does not authorise the carrying out of any work on land, or entering land outside his/her control.

If such works are required, it will be necessary for the applicant to obtain the landowners consent before work starts.

If the property is sold, the requirement to plant replacement trees passes to successive owners of the land.
