There are only 3 houses in our little cul-de-sac that have drive ways. We have had bins missed twice due to obstructions, I even struggle to get into the street. I have reported this issue to Selwood Housing and Wiltshire Council.

All these vehicles have drive ways and one even has two, but yet they choose to park in the entrance to the cul-de-sac which leaves us with very poor visibility when trying to leave or enter. Any support or advice would be greatly appreciated.

The photos (see below) were taken over two evenings, as you can see the van is very close to the entrance which means you "sneak" out. There are also vans and cars parked on the curb when you turn left so you are on the wrong side of the road till you come to little John. I have nearly knocked a kid off his bike and had a head-on with an ambulance, both no one's fault, but I wouldn't want that on my conscience. We are concerned that if the bin men can get in to empty our bins what if, God forbid, we would need the fire brigade? They would not be able to enter the street. The van at the end belongs to the property with two drives. They won't use the back one, next to mine, because they can't always get out, the silver car is blocking the drive, sometimes I struggle too, but they have their car in the front drive. The dark car person is an ambulance call handler so should know better, has an open back garden but doesn't use it as a drive, but had a sign up telling people not to park in front of it as access required. The small silver car in the first photo has a drive but picks and chooses when to use it. We as residents would like nothing more than to get yellow lines so our little road stays clear and safe for all to use.





Report: ANTI-SOCIAL BEHAVIOUR – FIELD NEXT TO PRIMROSE DRIVE PLAY AREA, HEATHER AVENUE

## 1 BACKGROUND

- 1.1 At the meeting of the Economic Development and Planning Committee of 25 May, the issue of anti-social behaviour at the field next to Primrose Drive play area, Heather Avenue was discussed.
- 1.2 It was resolved to ask the Economic Development Manager to investigate possible solutions with Wiltshire Council Highways and Wiltshire Police and bring the findings to this committee for consideration of the potential for a submission for the Community Area Transport Group.
- 1.3 The work outlined in 1.2 above has been completed.

# 2 ISSUE UNDER CONSIDERATION

- 2.1 It has been reported that young people on scooters are accessing the field next to Primrose Hill Play Area and their gathering is resulting in anti-social behaviour.
- 2.2 Drug use has been reported at this site.
- 2.3 The pathways between Heather Avenue, Daisy Close and Dorset Crescent are the reported access/egress routes to and from the site for scooters.
- 2.4 A solution to inhibit access for scooters is requested an accessible gate has been suggested, similar to that in Snarlton Lane.

#### 3 WILTSHIRE POLICE COMMENT

- 3.1 Wiltshire Police have confirmed they are well aware of this issue. They say it's a problem every summer and it's not just from scooter riders. The problem also embraces people arriving by cycle, cannabis users, and results in anti-social behaviour in the more general sense.
- 3.2 The issues are more focussed on the Nature Reserve than this Heather Avenue location
- 3.3 Some of the reports received by the police are known to concern legitimate users of the road/path to get to the field.
- 3.4 The police are aware of a drug dealer who occasionally uses the area, but this will be dealt with as a standalone issue.
- In terms of crime prevention; there's already a lot of natural surveillance there's lighting; the space is open; the environment is generally tidy and there's already an informal Neighbourhood Water and planty of private CCTV.

- 3.6 Wiltshire Police don't think that a 'design out' solution can be achieved at this location without disadvantaging legitimate users.
- 3.7 Where problem individuals do keep cropping up, the police are identifying them and steering them onto Early Intervention Schemes, or to the Youth Offending Team, to try and tackle the issues from that angle. Their view is that this seems to be quite an effective solution and it works on a much larger geographical area.

#### 4 WILTSHIRE HIGHWAYS COMMENT

- 4.1 The Economic Development Manager met the Senior Traffic Engineer for Melksham on site to view the problem location.
- 4.2 Wiltshire Highways understand the problem but confirm that the pathway under discussion is a designated cycle way. It is signed as such and, as therefore we cannot install a gate which would obstruct cyclists.
- 4.3 If a gate installation was possible, it was also thought that users would simply leave it open, defeating the object.
- 4.4 A number of ground installation options were also discussed but the overall conclusion was that a 'highways' solution to the issue was not possible or practical at this location.
- 4.5 Compounding the issue is the number of access points (at least 5, plus access via the nature reserve) and successfully impeding one would simply divert users to access via another.
- 4.6 An option would be to leave the paths as they are and simply fence the field. However, this would be costly, would impede machine access for maintenance and would involve increased hand machine work to cut and strim grass around the fence. And as the senior traffic engineer pointed out, users would likely just leave gates open, defeating the object of the work.

## 5 CONCLUSION

- 5.1 Wiltshire Police and Wiltshire Council Highways conclude that there is no effective and safe means to impede the access by scooter riders without disadvantaging and inconveniencing legitimate users of the routes and facilities.
- 5.2 Fencing off the field itself is not a practical or effective solution. This would also involve incurring additional ongoing maintenance costs.
- 5.3 Wiltshire Police also suggest that the issue is wider ranging than scooter riders and is occurring over a wider geographic area. They have solutions in place which they say are working.

# **6 RECOMMENDATION**

- 6.1 To note this report.
- 6.2 To note the conclusions of Wiltshire Council's senior traffic engineer and of Wiltshire Police.
- 6.3 To encourage local residents to keep reporting occurrences of anti-social behaviour to the police so they build up a picture of instances of anti-social behaviour and the locations where they occur.
- To consider this location as a possibility for future deployment of CCTV.

# 1 BACKGROUND

- 1.1 At the meeting of the Economic Development and Planning Committee of 25 May, the Economic Development Manager was asked to inspect the condition of the bus shelter opposite the entrance to Blenheim House Care Home and report findings to this committee.
- 1.2 The inspection outlined in 1.1 above has been completed.

## 2 ISSUE UNDER CONSIDERATION

- 2.1 See the location plan in Appendix 1. The bus shelter is located within Melksham Town.
- 2.2 The condition of the bus shelter is poor. It has no roof and, as such only offers limited shelter from weather from a north-easterly direction. The basic seating provision is still in place. A photograph of the condition of the shelter is in Appendix 2. The structure would appear to have originally been of an open fronted design providing basic shelter.

#### 3 CONCLUSION

3.1 The shelter is in very poor condition, is not currently fit for purpose, and requires substantial refurbishment or replacement.

# 4 RECOMMENDATIONS

- 4.1 To note this report.
- 4.2 To consider a funding request to the Community Area Transport Group for the provision of a replacement shelter.
- 4.3 To note that the Melksham Town Council budget, which provides financial match funding for Community Area Transport Group projects, is fully committed in 2021/22.

Report: Land East of Spa Road – response to planning concerns

#### 1 BACKGROUND

- 1.1 At the meeting of the Economic Development and Finance Committee on 16 February 2021, following representations from local residents, concerns were raised regarding the housing development at Land East of Spa Road, Melksham 14/10461, 18/04644 and 20/11601.
- 1.2 The concerns raised involved:
  - 1.2.1 the levels of the new development, particularly the level of the feeder road adjacent to 2-5 Farmhouse Court which appears to be approximately 1m above that indicated on the plans;
  - 1.2.2 new flooding problems at the site;
  - 1.2.3 that the ecological survey carried out by the site developers apparently failed to investigate the pond in the grounds of Berkeley House, some 35m west of the development. It is thought that this site may host a colony of Great Crested Newts, a protected species.
- 1.3 The written response to the issues raised, from the Wiltshire Council Planning Enforcement Team was received 24 June 2021.

# 2 WILTSHIRE COUNCIL PLANNING ENFORCEMENT RESPONSE - DRAINAGE

2.1 The drainage at the site has now been signed off by the Wiltshire Council drainage team who have visited the site on a number of occasions; they are satisfied all drainage is in accordance with the approved plans.

# 3 WILTSHIRE COUNCIL PLANNING ENFORCEMENT RESPONSE - ECOLOGY

- 3.1 The developers instructed an ecologist to look at the newts photographed by a complainant after claims that Great Crested Newts were found dead near by the site. An ecologist from the Council also viewed these photos and both were satisfied that they were not Great Crested Newts.
- This matter was also reported to the Wildlife Crime Officer at Wiltshire Constabulary.

  The Wiltshire Planning Enforcement Officer does not have an update regarding the conclusion to their investigations.
- 3.3 The ecologist employed by the developer has taken time to go onto the site and ensured all works are being carried out sensitively and minimising disturbance.

## 4 WILTSHIRE COUNCIL PLANNING ENFORCEMENT RESPONSE – SITE LEVELS

- 4.1 Concerns were raised by this committee, following representations from nearby residents, that the level of this development was higher, by around 1m, than the plans indicated. This related particularly to the feeder road constructed between 2-5 Farmhouse Court.
- 4.2 Wiltshire Council Planning Enforcement was informed of this concern, but to date, has not offered a specific response.

## 5 RECOMMENDATIONS

- 5.1 To note this report featuring responses from Wiltshire Council Planning Enforcement to some of the concerns raised by this council.
- 5.2 That the author should request a response from Wiltshire Council Planning Enforcement regarding the levels of the developments on the site.
- 5.3 That the author should contact the Wildlife Crime Officer at Wiltshire Constabulary to request the conclusion of their investigation regarding ecology.

## 1 PARISH STEWARD WORKS

- 1.1 The Parish Steward scheme delivers a special highway trained operative(s) to deliver small scale, discretionary, local highway priority works to town and parishes in Wiltshire. In essence if one man and a van can undertake the work without mechanical assistance, it is within scope. If mechanical assistance is required, it is out of scope.
- 1.2 Whilst the local Highways discretionary service is delivered by the Parish Steward Scheme, statutory and safety works are undertaken through the MyWiltshire System see section 2.0 below.
- 1.3 The scope of works commonly undertaken by the Parish Steward is detailed in Appendix 1. This list is not exhaustive but gives an indication of common tasks.
- 1.4 The Parish Steward visits Melksham periodically. The proposed schedule of visits in summer 2021, by the team to the town, is outlined in Appendix 2. The schedule of the Parish Steward visits to a particular settlement in Wiltshire is based upon the geographical size of the parish or town.
- 1.5 Any works requested in Melksham should be notified to Taylor Robinson (taylor.robinson@melksham-tc.gov.uk) a week prior to the start of the scheduled visit.
- 1.6 On occasion, the work of the Parish Steward can be focussed solely on a priority area for a period of time, according to need.

# 2 MY WILTS ONLINE REPORTING

- 2.1 My Wilts is the new way to report issues to Wiltshire Council and replaces the MyWiltshire app.
- 2.2 The Parish Steward Scheme is only for discretionary works. Any statutory work (potholes, damaged statutory signs, etc.) should be entered on to the My Wilts System for Wiltshire Council to inspect and assess the appropriate response. This is because leaving statutory or safety work to the next Parish Steward visit could slow the response time and could put the safety of highway users at risk.
- 2.3 You can use the My Wilts app to report issues in Wiltshire, for example:
  - 2.3.1 Abandoned vehicles
  - 2.3.2 Fraud
  - 2.3.3 Weather emergencies
  - 2.3.4 Fly Tipping
  - 2.3.5 Dog mess

Over time Wiltshire Council will be adding more services to MyWilts, making it simpler, quicker and easier to access Wiltshire Council services digitally, when you choose to.

3.1 You can download the new app from the App Store (Apple) / Google Play (Android) by searching for 'My Wilts'.

## 4 MY WILTS ONLINE REPORTING - USING THE APP

- 4.1 Open the app.
- 4.2 Sign in to My Wilts by clicking on the icon on the right-hand side and selecting the Sign in/Register option.
- 4.3 If you don't already have an account you will need to register before you can sign in.

- 5.3 Submit details of appropriate, discretionary highways works to Taylor Robinson at the town hall for the Parish Stewart team to attend to.
