The ballpark estimate of £6,000 for the lowering/diversion of underground services should the improvements be carried out was noted. The Town Mayor, Councillor Hubbard, stated that Councillors

UNANIMOUSLY RESOLVED to recommend the introduction of a 20mph speed limit on Union Street to CATG. If the 20mph limit was adopted the Council would purchase a Speed Indicator Device (SID) unit specifically for Union Street. A meeting would be organised with Mark Stansby to review options already considered and discuss additional options to reduce speeding on Union Street.

180/21 A350 Melksham Bypass - Second Public Consultation Report

The publication of the A350 Melksham By-Pass report following the second public consultation was noted.

181/21 Asset of Community Value - ACV/2021/00012 - Land north-west of Woodrow Road Melksham SN12 7AJ

The decision made by Wiltshire Council to list the land north-west of Woodrow Road, Melksham as an Asset of Community Value was noted.

The Town Mayor, Councillor Hubbard, explained that the Town Council currently lease the land and that should the owner want to sell the land, as an Asset of Community Value, they would have to go through a statutory process, give notice and offer the community the opportunity to purchase the land in the first place. The current lease is in place for five years.

Councillor Rabey confirmed that there are currently no electric vehicle charging points in the town centre as the ones in King Street car park have been out of action for several months and are unlikely to be replaced by Wiltshire Council until 2022/2023.

UNANIMOUSLY RESOLVED that the Town Clerk be asked to write to Wiltshire Council with the following queries:

- Has the tender process started for replacing the electric vehicle charging points? If not when will it begin?
- When will the tender be awarded?
- When is it anticipated that replacement electric vehicle charging points will be installed?
- What specification has been included in the tender for the charging points, i.e. KW capacity and number of points?

The Campus

- Can the specification of the charging points to be installed at the Campus be provided?
- When will the charging points be available for use?



IF ALL THE SPACES ARE TAKEN THE NEAREST PLACE TO PARK IS IN ONE OF THE CAR PARKS AT THE OTHER END OF THE TOWN, AT WHICH PARKING FEES ARE DUE FOR THE DAY. THIS CAN CAUSE PROBLEMS NAMELY THE COST FOR PERMIT, PROBLEMS IFRESIDENTS ILL OR DISABLED AND RESIDENTS SAFETY AT NIGHT WHIST WALKING BACK TO THE ALMSHOUSES

THE MAJORITY OF THE PARKING IS TAKEN UP BY AVON WORKERS ON THE ADJACENT FACTORY SITE (WHO ALREADY HAVE ADEQUATE PARKING ON THEIR OWN SITE) AND BUSINESS PEOPLE WORKING IN MELKSHAM.

THE SET OF PARKING SPACES ADJACENT TO THE ALMSHOUSES WAS WITH THE HELP OF TOWN COUCIL MEMBER AND ALMSHOUSES TRUSTEE PAT AVES PREVIOUSLY CHANGED FOR SOCIAL AND FINANCIAL NEEDS FROM A "WITH TIME RESTRICTION" TO 24 HOUR FREE PARKING WITH THE ABOVE PARTICULAR NEEDS OF THE RESIDENTS OF THE ALMSHOUSES TAKEN IN MIND.

Setting up a Community Speed Watch

Community Speed Watch (CSW) is a scheme which gives local people the power to help reduce traffic speeds and improve the quality of life in their community.

Changing the attitudes of drivers is key to reducing speed. CSW is about taking positive action, working together to educate and reinforce the importance of reducing speeds in our town and villages across Wiltshire & Swindon.

Motorists caught speeding by volunteers are sent a warning letters from the police. Further action is taken against persistent offenders with their details being passed to their local Community Policing Teams for action.

The main objectives are:

- To secure a reduction in vehicle speeds to prevent collisions
- To improve quality of life
- To reduce noise pollution
- To raise public awareness of inappropriate speed.

Your traffic survey results

Once the traffic survey has been completed by either Wiltshire Council or Swindon Borough Council and it fits the criteria for a CSW team, the following are required;

- You'll need at least 3 6 residence willing to undergo training to become CSW volunteers.
- A Team Leader from the volunteers chosen the team leader and nominated to undergo Non Police Personnel Vetting level 1 (NPPV1).
- The Team Leader will be responsible for;

1. Administration

- Use DutySheet to log future sessions.
- To collate all Speed Watch results, using MS Excel to the CSW Support Team.

2. Communication

- To circulate details of speed check activity to team members
- To circulate relevant updates from CSW Support Team to team members.
- To assist the CSW Support Team with any enquiries as appropriate.

3. Training

To provide training details to NEW potential team members. Ensure paperwork is complete prior to training and following training.

4. Equipment

• To be the contact for the maintenance of the SL700 Unipar device.

5. Marketing/Promotion

 To work as part of a wider team to develop Community Speed Watch within the force area.





Subject: Melksham Campus - Pre Consultation on Parking Restrictions

I am writing to you as part of the pre-consultation for the introduction of an Off Street Parking Order at Melksham Campus.

One of the pre-occupation Planning conditions for the campus is that we have approval in writing from the Local Planning Authority of a car parking management plan for the campus car parks in order to achieve reasonable availability of on-site car parking spaces for users of the campus. The plan also needs to be implemented prior to occupation. Given the close proximity of the car park to the town centre, we feel it is important that a restriction order is in place so that spaces are prioritised for users of the campus facilities.

We propose that all of the areas outlined and highlighted in yellow will be covered by the Order.



In order to ensure reasonable availability of parking spaces for users of the campus and after considering options, we propose the following restrictions:

- Three hours free parking in a marked bay
- Restriction time 8am-6pm Monday to Sunday (except Bank Holidays)

Additional information:

- Customers will retrieve a ticket, displaying the time of arrival, from a parking machine which they will display in their vehicle
- There will be one solar powered parking machine in each of the three car park areas
- Parking restriction signage will be placed in each car park
- There are 17 accessible, 12 family and six electric vehicle (also accessible) parking spaces across the car parks
- The car parks will be regularly patrolled by Parking Enforcement Officers
- The car parks have CCTV and associated signage which will also act as a deterrent to mis-use of the car parks
- Campus staff will be able to arrange for extended stays for visitors attending events that extend beyond three hours
- Campus staff will be issued with virtual permits which enable them to park at the campus site beyond three hours
- On-site clubs and tenants of the campus will be issued with permits to enable them to park at the campus site beyond three hours (number of permits to be negotiated with the individual organisations)
- A formal consultation process on these restrictions will take place in the coming weeks.
