24/25 Apologies

Apologies were received from Councillor Calland, who was subbed by Councillor A Westbrook

25/25 Declaration of Interest

There were no declarations of interest.

Councillor Elson did declare an interest in Friends of Gifford Surgery but the Chair advised that as this was under public participation rather than an agenda item the declaration was not required.

26/25 Minutes

The Chair noted that she had abstained from the vote on the Melksham Food & River Festival Core Grant because of her connection.

Subject to this correction, the minutes of 16th June 2025, having been previously circulated, were approved as a correct record and signed by the Chair Councillor A Westbrook.

27/25 Public Participation

Two representatives of Friends of Giffords Surgery spoke about their wish to run a Christmas Day Lunch in the Assembly Hall. The Chair advised that the decision was for operational staff, not for the council and that a member of staff must be available at the event for insurance reasons. The CEO/Town Clerk advised that she was discussing options with members of staff.
